ABSTRACT

Urban food systems in developing countries like India are rife with inequalities that preclude food security for all. In this context, the paper examines the role played by informal workers in the 'circular economy' for food in improving the accessibility of food and urban food security in Delhi, India. Evidence from an informal street market close to one of the country's largest urban wholesale markets of food grains, pulses and spices in Delhi reveals rare details of how urban food waste plays a significant role in the livelihood strategies of the city's poor migrants while also contributing to the urban food security of the low-income households. Although there is a growing recognition that the street food sector plays an important role in urban food security, the vital role played by waste collectors, home-based workers and street vendors in restoring discarded food grain, pulses and spices, and bringing them back into the urban food system has been largely invisible. This invisibility extends to the gendered segregation of work in food waste recycling, where our study found that predominantly women undertake labour-intensive and lower paid tasks at the bottom of the hierarchy.

ABSTRACT

Despite policies aimed at reducing child marriage, the practice persists. Using data from the National Family Health Survey-5 (2019–21), we explore whether young women aged 15–29 who marry in childhood (before 18) or late adolescence (ages 18–20) are disadvantaged compared to those marrying later. Findings show that even after adjusting for confounding factors, those marrying in childhood or late adolescence are more likely than others to hold traditional gender role attitudes, fear their husbands, and face controlling behaviour and violence within marriage; and less likely to control resources, make decisions and enjoy freedom of movement. Initiatives must empower women to exercise rights and build new notions of masculinity and femininity.

ABSTRACT

There is large evidence on efforts that are aimed at informing on benefits of institutional delivery in reducing maternal mortality. However, the critical role of transport infrastructure in accessing and improving maternal care in India is underexplored. This paper discusses how different dimensions related to transport infrastructure create barriers in accessing maternal healthcare services. Empirical analysis show distance, absence of transport, choice of the mode of transport and its cost often increase barriers for women in accessing health facilities. Such transport-related barriers are often higher among socio-economically vulnerable and rural women. Attention to mobility and transport while designing maternal care policies will contribute to improving lives of mothers and children.

**Supplements among Pregnant Women - Insights from NFHS
2015–16 and 2019–21, By - William Joe and Et.al.,**

ABSTRACT

Consumption of iron and folic acid supplements is critical for preventing and treating anaemia among pregnant women in India. This paper analyses two rounds of the National Family Health Survey 2015–16 and 2019–21 data to present national-level trends and patterns in the receipt (or purchase) and consumption of IFA supplements during pregnancy. The NFHS 2019–21 reveals that 88% of women (15–49 years) have received IFA supplements during their last pregnancy and 44% have consumed IFA for more than 100 days. Antenatal care-related correlates have a significant influence on the receipt and consumption of IFA supplements. In particular, ANC by skilled providers (doctors or ANMs) and the sharing of health and nutrition information by front-line workers has a significant impact on IFA consumption. The paper also finds significant trend improvements in IFA provisioning and consumption after the launch of Anaemia Mukht Bharat in 2018.

- **Influence of Internal Migration and Gender on Maternal Healthcare Services Utilisation in South Indian States: Evidence from NFHS-4 and 5, By - Tijo George & Mala Ramanathan**

ABSTRACT

Migration is a means of survival for individuals who are poor both globally and in India. While male migration is a common focus of research, the significant contribution of female migrants to the total number of migrants within India cannot be overlooked. Migration can disrupt existing gender norms, affecting women's healthcare either by improving or adversely affecting health of women migrants. This study examines how migration status and gender norms affect maternal healthcare utilisation among married women in south Indian states using NFHS-4 and 5 data. When compared to intra-state migrants, interstate migrant women had a less chance of utilising antenatal care and delivery at health facilities in 2015–16. This trend was reversed by 2019–21. Utilisation of maternal care services for interstate migrant women was operationalised through their reduced autonomy to act for their health. Therefore, health systems should ensure that these whose healthcare-seeking

autonomy may be compromised, are brought within the pale of maternity care services.

ABSTRACT

This study examines the relationship between women's empowerment and economic growth, utilising data from the National Family Health Surveys spanning from 2006 to 2021. Our findings reveal: (i) a positive influence on economic empowerment but a more subdued, if not negative, effect on women's agency; (ii) significant but minor associations of state gross domestic product with all women's empowerment indicators; (iii) economic empowerment factors such as bank account ownership and employment demonstrate the highest responsiveness to gross domestic product. Visual inspections show that the predictive capacity and association of economic growth on women's empowerment decreases with rising SGDP at individual and ecological levels, respectively.

The article reflects on the socio-economic and cultural barriers to health literacy and proposes the

need for comprehensive, community-focused programmes.

ABSTRACT

The National Family Health Survey in India was initiated in 1991 with the idea of providing estimates of various demographic and health parameters for its different states as well as the country. Due to growing demand for the data at a lower administrative level, the objective was later shifted to presenting the estimates at the district level of a state. This resulted in a manifold increase in its sample size and hence the need for paying adequate attention towards controlling the non-sampling errors. The paper discusses a few areas of non-sampling errors that are crucial in maintaining the sanctity of the estimates. It also indicates that for monitoring family planning and maternal and child healthcare programmes at district level, there are alternative ways to estimate the parameters and avoid using a large-scale survey like NFHS.

ABSTRACT

This paper provides a comprehensive update on the data collection issues for all five waves of NFHS and a detailed discussion of the allied quality concerns with a special focus on the most recent round, NFHS-5. More specifically, we have examined certain aspects of data collection, including the size of the questionnaire, duration of the interview, fieldwork organisations, quality checks for certain outcomes, and overflow and non-utilisation of the data. In the last five rounds, the size, dimensions, and utility of NFHS data have grown phenomenally. Concerns related to the quality of data have increased with the increase in the size of the survey. A considerable rethinking and effort is still required in the selection of survey organisations, sample size, and the number of questions.

ABSTRACT

Understanding trends in the extent of violence against women can be helpful in challenging violence against women and gender inequality. In this paper, we compare the incidence of violence, as measured in the National Family Health Surveys, to the reporting of violence, as compiled by the National Crime Records Bureau. We also shed light on heterogeneity in incidence and reporting across India's states. We find that violence against women is common, that most violence against women is not reported to the police, that violence by husbands is less likely to be reported than violence by others, and that the reporting of violence has not improved over the last decade and a half. These concerning findings highlight the urgent need for social and legal interventions to reduce violence against women, and to improve its reporting.

ABSTRACT

Parental income is vital in providing nutritional security for children and adults alike. Due to a lack of employment opportunities in agriculture-dominant rural areas, people, particularly in low- and middle-income countries, migrate to the service and construction sector-dominant urban areas. Despite the humongous scale of this migration, the association between paternal informal migration and the nutritional status of the children is under-researched in India. Some studies show a positive association while others show a negative or no association. This study aims to explore this relationship using data from the National Family Health Survey-5 collected during 2019–21.

Communities in North East India are prone to various social and geographical vulnerabilities leading to poor health outcomes. This paper assesses various geographical vulnerabilities and their association, particularly with reproductive, maternal, newborn and child health outcomes. Multivariate logistic regression and univariate and bivariate Local Indicators of Spatial Association methodologies were used to study the effects of various vulnerabilities faced by women, using National Family Health Survey-5 data (2019–21). The findings can be utilised in developing regionally tailored and targeted interventions to address localised needs and improve the overall health status.

ABSTRACT

In this paper, we adopt a Southern feminist epistemology to critically appraise the ways in which media discourse on gendered organizing during the Indian COVID-19-induced migrant crisis resists or reinforces hegemonic caste hierarchies. To contextualize this work, we briefly historicize scholarship on feminist organizing around land rights, hunger, and violence, while noting the politics of contagion and pollution narratives plaguing the pandemic discourse in India. After conducting a qualitative content analysis (QCA) followed by a critical discourse analysis (CDA) of media discourses across three tiers (international, national, and local), we found that international and national tiers of discourse largely deployed a savarna gaze that worked to 1) Reinforce brahminical and technocratic pandemic narratives and 2) Delegitimize Dalit marginal organizing feminist work and Dalit sensibilities through seven overlapping metrics of erasure.

ABSTRACT

Research on crisis have brought to fore the necessity of studying the gendered impact of such events. Covid-19 too has shown how gender relations play a role in the political economy of crisis, relief and response as well as recovery. This article focusses on the experiences of paid domestic workers in India who are among the most invisible and marginalized of India's informal workers and largely excluded from labor discourse and employment legislation. With Covid-19, the precariousness characterizing the sector has also been further exposed and exacerbated, with vast numbers of workers now facing significant challenges to livelihood, as well as several new/additional pressures and risks, both at work and at home. In this article, we examine these Covid-related challenges, drawing on interviews conducted with domestic workers, NGO practitioners, and labor rights' activists in Delhi and Kolkata between April and August 2020. We show how, during the national lockdown, many domestic workers in these cities experienced increased insecurity related to jobs and housing, as well as an increased control and surveillance at home.
