## ABSTRACT

Through this paper I wish to highlight the earnest contribution that self-narratives have made in the study of Patriarchal institutions. The organization of Patriarchy requires the appropriation of identities at various levels. Its sustenance depends on how widely these appropriated identities

are made viable at various sites of culture such as cinema, arts and literature. The co-opting of these sites results in signifying the gendered binary upon which Patriarchy rests. It was long held that modernity was an exclusive product of the historical processes in industrial Europe of the 18th century. Such a proposition allowed institutions like Patriarchy to sustain within colonized societies like India as an anti-thesis of modernity.

### **ABSTRACT**

In a matrilineal society, where women own land, one would expect women would hold the seat of power and be treated with respect. However, while women are treated with immense respect in the rural areas of Meghalaya, India, domestic violence, child marriage, and the lack of family planning impact the empowerment status of women. In Meghalaya, non-governmental organisations (NGOs) and self-help groups (SHGs) play a very pivotal role in women's empowerment by providing basic education, vocational training for self-employment, legal aid, protection for woman, and self-awareness programmes. To understand Meghalaya's contraceptive use and fertility rates despite it being a matrilineal society, this study investigated the roles of the government, NGOs, SHGs, and village leaders in educating women on the repercussions of child marriage, combating domestic violence, and the advantages of family planning.

## **ABSTRACT**

This paper explores young people's understandings of gender and sexual violence in New Delhi, India, based on multi-method research conducted with young people (aged 15–17) in three co-educational secondary schools. Fieldwork took place shortly after the 2012 Delhi gang rape that sparked widespread debates about violence against women in India, and so sexual violence became an important frame for students' discussions around gender and sexuality. Young people's understandings are considered within gender narratives – of 'can-do' and 'vulnerable' girlhood, and of 'hero' and 'good boy' masculinities – which already shaped their day-to-day experiences of schooling.

## **ABSTRACT**

Despite the growing body of research on the emotion of disgust – including its relationship to political ideology, moral judgment, matters of sex and sexuality, and death – the global reproductive rights movement has paid relatively little attention to the role disgust plays in the debate over abortion. By focusing on the right of a woman to make her own decision about an unwanted pregnancy, the pro-choice community has allowed anti-choice groups to define and frame the abortion procedure, abortion providers, and women who have abortions in terms associated with disgust.
